MARKET LEADING AGENT HRA ADMINISTRATIVE FEE

- Clever Care will pay agents an additional administrative fee including:

 - \$70 for completed HRAs with 2024 Longevity (HMO) plan enrollments

Obtaining a Health Risk Assessment (HRA) document for new Clever Care members is essential in creating a comprehensive care plan with the member, which may identify gaps in care, lead to improved management of chronic conditions, and healthier, more satisfied members. We understand that submitting an HRA for new enrollees requires additional time and resources on your part, so we are extending the time you have to complete HRA forms:

EXTENDED HRA COMPLETION WINDOW

HRAs must be completed and submitted electronically to Clever Care for any members with an effective enrollment date of 5/1/24 through 7/1/24, **up to 10 business days after the member's effective enrollment date.**

• Note that all HRAs must be submitted electronically to Clever Care along with a CMS approved application
